- Canopy Seating (2 Canopies w/ 8 Tables)

Outside food is permitted, supplies are not included. Access gate to Turtle Splash Water Park will be locked. Balloon and table-top decorations are permitted, no taping of signage is allowed.

Please note, you do not have the option to reschedule your rental the day of (one weeks' notice must be given for any rescheduling).
