Private rentals of Toucan's Hideaway are two hours in length, and include:

- Canopy Seating (2 Canopies w/ 8 Tables)

Outside food is permitted, supplies are not included. Access gate to Turtle Splash Water Park will be locked. Balloon and table-top decorations are permitted, no taping of signage is allowed.
